## Frequently Asked Questions

### **What is the Community Foundation?**

The Community Foundation Serving Greeley and Weld County has been working to improve the quality of life in Weld County since 1997. It is an organization dedicated to encouraging and managing the philanthropic efforts of individuals and organizations in Weld County. Since 1997, the Community Foundation has awarded over \$1.5 million in scholarships to students.

### **What is the Community Foundation Scholarship Application?**

The Community Foundation offers a variety of scholarships to provide resources for a range of educational opportunities including accredited vocational schools and two- and four-year colleges/universities. The Community Foundation Scholarship Application allows you to apply for several different scholarships using one application and submitting one set of application materials (additional copies are required). All Community Foundation scholarships **require an application, two letters of reference/recommendation; a current transcript of grades including class rank and ACT scores (or GED certificate of completion); a personal statement and a copy of the FAFSA Student Aid Report or Tax Form 1040. You will be required to submit five (5) copies plus the originals (6 total) of every item except the transcript of grades and the FAFSA Student Aid Report or Tax Form 1040.**

### **How are eligibility requirements determined?**

Scholarships are available through the Community Foundation thanks to the generosity of donors who have established scholarship funds. Each donor determines the eligibility criteria of their scholarship. Scholarships may focus on academic achievement, academic potential, community service or financial need. *Please note: Applicants who are current employees or members of the Community Foundation's Board of Directors or who are related to employees or members of the Community Foundation's Board of Directors are not eligible to apply; this includes applicants that are a child, stepchild, grandchild, great grandchild, spouse, brother, sister, brother-in-law, or sister-in-law of any employee or member of the Board of Directors of the Community Foundation Serving Greeley and Weld County.*

### **What if I am not a "straight A" student?**

The Community Foundation offers scholarships for a variety of students. While academic performance is important to the scholarship advisory committees, it is not the only criteria for scholarship applicants.

### **What if I am not sure where I will be going to school?**

If you are unsure, you should indicate your first and second choice. Once you have made your final decision, please notify the Community Foundation.

### **May I apply for more than one scholarship?**

By completing the Community Foundation Scholarship Application, you will automatically be included in any scholarship pool for which you are eligible.

### **How much will I receive if I am selected as a recipient?**

Awards for each scholarship vary depending upon the criteria. Scholarships range from \$500 to up to \$5,000, with the average award being \$1,000. Please see specific scholarship information for award amount on our website at [www.cfsgwc.org/scholarships](http://www.cfsgwc.org/scholarships).

### **How many scholarships does the Community Foundation award?**

Community Foundation scholarships are awarded from endowment funds. The scholarships we award are dependent upon the investment market. The number of scholarships awarded will vary from year to year.

### **Do I receive a check if I am awarded a scholarship?**

No. All scholarship checks are made payable to your school and go directly to your school's financial aid or scholarship office. There is no exception to this rule. Checks are sent to schools in August upon receipt of necessary paperwork and other verification requirements provided by you or the school.

### **Are scholarships taxable?**

For degree-seeking students who use the scholarship for qualified tuition and related expenses within the meaning of IRC § 117(b)(2), it is not taxable. The Community Foundation recommends that you and/or your parents consult a tax expert or your school's financial aid office for advice.

### **If I receive a scholarship one year, will I automatically receive it the following year?**

No. While a few scholarships are renewable, others are one-time only. Each scholarship varies; please visit our website at [www.cfsgwc.org/scholarships](http://www.cfsgwc.org/scholarships) for scholarship specifics.

### **Does the Community Foundation make the decisions about who is awarded?**

Each scholarship fund has an advisory committee who makes recommendations to the Community Foundation Board of Directors for their approval.

### **Will my personal information be shared?**

No, your application information will not be shared with anyone except Community Foundation staff and the advisory committee. Financial information (SAR or 1040 form) will be held at the Community Foundation and will not be shared with the Scholarship Advisory Committee. Please mark out all but the last four digits of your social security number if it appears on any of the documents you submit with your application.

### **When will I be notified?**

All applicants are notified in writing of the status of their application by the end of April. The Community Foundation hosts a scholarship reception in May to present a certificate to the winners and also give the students a chance to meet living donors.



## **Other awards available NOT using the CF Scholarship Application**

*Please check with your school counseling office for other scholarship opportunities.*

### **Peschel Memorial Scholarship Fund**

**Designated for:** A graduating senior from Valley High School who is pursuing additional education in an agriculture major.

**College Enrollment:** Any accredited two or four-year college or University.

**Other Criteria:** Must be a member of the Valley FFA Chapter and have completed the program of agricultural education at Valley High School.

**Scholarship Amount:** \$1,000.

**Application Information:** The application is available in the counseling office at Valley High School or the Valley H.S. Ag-Ed Department and is due by April 5th.

### **SasonsFund Scholarship Fund**

**Designated for:** One student from Greeley Central High School, Greeley West High School and a third student from Wasson High School.

**College Enrollment:** Any accredited four-year University.

**Minimum GPA:** 3.0

**Other Criteria:** Must be active academically and athletically.

**Scholarship Amount:** \$1,500.

**Application Information:** The application is available on the Community Foundation website or the counseling office at each of the three high schools. Please check with the counseling office at each high school for the deadline submission date.

### **Winograd Family Fund Scholarships**

**Designated for:** One student from Greeley Central High School, Greeley West High School and a third student from Northridge High School.

**College Enrollment:** Any accredited Colorado two or four-year college or university.

**Minimum GPA:** Must be in upper 40% of graduating class.

**Special Preference:** All qualifications being equal, preference shall be given to a member of a minority group.

**Scholarship Amount:** \$1,200.

**Application Information:** The application and deadline is available at the counseling office at each of the three high schools.





# Application Instructions

We recommend you send your application and all of the supporting documents to us in one envelope. Please be sure to mark each item with your name and do not use staples.

- 1. Application** (pages 6-8) (please include the original plus 5 copies; a total of 6)  
Applications must be complete to be considered. **Do not staple documents.** Make sure all pages include applicant's name. All correspondence will go to the address you specify on your application.
- 2. Letters of Recommendation** (visit [www.cfsgwc.org/scholarships](http://www.cfsgwc.org/scholarships) for tips on writing effective letters of recommendation) (please include the originals plus 5 copies; a total of 6)  
Provide two letters of recommendation limited to one page each. Additional letters will not be considered.
  - One letter from a teacher, coach or academic advisor (non-family member);
  - One letter from a work or volunteer supervisor, a youth leader or personal acquaintance (non-family member and not from a teacher, coach or academic advisor).All letters must be signed and dated. Photocopies are acceptable.
- 3. Current Transcript of Grades, Class Rank and ACT Scores or GED certificate**  
All applications must include a current official high school transcript **including class rank and ACT scores** in an official and sealed envelope. If you have received your GED, include your certificate of completion. If you have taken college courses, an official college transcript must also be included for all work completed. Photocopies and copies from the Internet are unacceptable.
- 4. Signed and Dated Personal Statement** (please include the original plus 5 copies; a total of 6)  
Include a typed statement (double-spaced up to two pages). In the statement, you should include:
  - A brief history about your background including information about your family influences.
  - Your life goals and what you hope to achieve.
  - Describe how you have been a positive role model in your school or community and your plans to incorporate service and volunteerism into your immediate future.
  - Who or what has been the biggest influence in your decision to pursue additional education in your chosen field? Why?
  - Describe any special circumstances that may affect your family's ability to pay for college (medical, divorce, unemployment, child support, other).
- 5. Financial Need**  
If you applied for federal financial aid, enclose a copy of all pages of your 2012-2013 Student Aid Report (SAR). For more information, see [www.fafsa.ed.gov](http://www.fafsa.ed.gov). If you did not apply for federal financial aid, enclose a copy of the first two pages of your parent's or guardian's most recent Federal Tax Form 1040 (or your own if you are not a dependent). Please note: this information will be held at the the Community Foundation and will not be given to the Scholarship Advisory Committee.
- 6. Application Checklist**  
Your completed packet should include:
  - A completed and signed application form (pages 6-8) (please include the original plus 5 copies; a total of 6)
  - Two (2) letters of recommendation limited to one page each (please include the originals plus 5 copies; a total of 6 per letter)
  - Signed and dated personal statement (please include the original plus 5 copies; a total of 6)
  - Include an OFFICIAL copy of the required transcript including class rank and ACT scores (or GED certificate of completion)? (original copy only)
  - FAFSA Student Aid Report or Federal Tax Form 1040 (original copy only)
